G1 Mixed Species

All trees throughout the wooded strip of land running around the eastern and northern boundary lines of site - Level 2 survey required

A1 All Ivy clad trees not possible to carry out full inspections - Sever Ivy at base

G2 Laurel

Covering footpath - Crown lift to give 3.0 metres ground clearance

T2 Lawsons Cypress

Dying, Poor condition - Fell by way of controlled dismantle carefully using climbing and manual sectional dismantle techniques down to ground level or as close to grade as possible

T3 Sycamore

Deadwood within crown - Remove major deadwood through out entire canopy

T6 Lawsons Cypress

Dying, poor condition - Fell by way of controlled dismantle carefully using climbing and manual sectional dismantle techniques down to ground level or as close to grade as possible.

T8 Giant Redwood

Deadwood within crown - Remove major deadwood through out entire canopy.

T9 Cedar

Deadwood within crown - Remove major deadwood through out entire canopy.

T10 Giant Redwood

Deadwood within crown - Lateral crown reduction by pruning off 2.5 metres growth back to suitable growth points on branches overhanging playground area.

Remove major deadwood through out entire canopy.

G3 Bramble

Coming through in to playground area and toys - Cut down to ground level to give 3.0 metres clearance from playground fence line.

G4 Laurel

Overhanging parking area & turn circle - Crown reduction by removing 3.0 metres growth in height and spread pruning back to suitable growth points to leave a balanced crown. Using hand tools only to give the best finishing cuts.

T11 Sycamore

Deadwood within crown - Remove major deadwood through out entire canopy.

T12 Cypress

Dying, poor condition - Fell by way of controlled dismantle carefully using climbing and manual sectional dismantle techniques down to ground level or as close to grade as possible.

T13 Corsican Pine

Deadwood within crown - Remove major deadwood through out entire canopy.

T14 Cedar

Deadwood within crown - Remove major deadwood through out entire canopy.

T15 Maritime Pine

Deadwood within crown - Remove major deadwood through out entire canopy.

T16 Beech

Deadwood within crown, Branches close to building - Remove major deadwood through out entire canopy. Prune back from building to give 3.0 metres clearance.

T17 Ash

Ash dieback, tree in decline - Fell by way of controlled dismantle carefully using climbing and rigging techniques down to ground level or as close to grade as possible.

T19 Ash

Ash dieback, tree in decline - Fell by way of controlled dismantle carefully using climbing and rigging techniques down to ground level or as close to grade as possible.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

### Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
